HW Superintendent Porter here to present his report as follows;

Town of Galen Highway Report 7-14-2025

- > Sunderville rd. culvert pipe has been replaced with the assistance of Walworth highway department whom supplied their mini excavator and men.
- Chip sealing has been completed sealing 13.6 miles of road with the assistance of the towns of Savannah, Lyons and Rose.
- ➤ 1.1 miles of old route 31 has been shimmed and paved with hot mix asphalt. I have been working with Wayne County highway department to schedule putting shoulders on this

- road, hope to have it done in the next couple of weeks by using their widener and having Chris Hubbs come in to operate it
- * #8 truck is in for repairs from last winter's steer tire blowout and a blown turbo charger that occurred during our paving project
- > The 2025 F550 has been delivered and put into service
- ➤ Bentley rd. (peaceful valley) is becoming eroded underneath by the Clyde River. We have put rubble rock in the river and plan to wedge the pavement with hot mix where damage has occurred.
