- Culvert pipe on Bentley Rd has been replaced.
- Perry Rd and the dirt section of Turnpike Rd (Skunky Hollow) have been graded and stone added
- > Shoulders have been installed on both new sections of Old rt 31 completing the project
- Much of the past month was spent returning in kind services to other towns and Wayne County Highway Department
- We have replaced 1 culvert on Ganz Rd and plan to replace the remaining 3 culverts this week
- ➤ The 2016 F250 is currently listed on Auctions International for surplus
