Executive Session (As Needed)

(Items which can be discussed in executive session as specified in Public Officers Law §105.)

1. Matters which will imperil the public safety if it is disclosed;
2. Any matter which may disclose the identity of a law enforcement agent or informer;
3. Information relating to current or future investigation or prosecution of a criminal offence which would imperil effective law enforcement if disclosed;
4. Discussions regarding proposed, pending or current litigation;
5. Collective negotiations pursuant to article fourteen of civil service law;
6. Medical, financial, credit or employment history of a particular person or corporation, or matters relating to appointment, promotion, demotion, discipline or removal;
7. Preparation, grading or administration of examinations;
8. The proposed acquisition, lease or sale of real property or the proposed acquisition of securities, or sale or exchange of securities held by such public body, but only when publicity would substantially affect the value thereof.
