IN ORDER FOR THE FIELD INSPECTOR TO PERMIT THE EVENT TO OCCUR, **EACH** ITEM SHOWN OR STATED CLEARLY ON THE APPROVED PLANS SHALL BE CONSISTENT WITH THE CONDITION OBSERVED BY THE FIELD INSPECTOR OR THE PERMIT WILL NOT BE APPROVED.

Submit a full site plan and floor plans to scale denoting:

- a. The area of the tent installation including support ropes.
- b. Fire lanes.
- c. Nearest existing fire hydrant.
- d. Distances to property lines, buildings, other tents, and vehicles.
- e. Location of heating units.
- f. Location of generators and fuel tanks.
- g. Wiring routing on floors, how secured and ramped over.
- h. Floor plan of the tent, including all tables, chairs, aisles, stages, switchboards, buffets, fire extinguishers, exits, exit signs, LP-gas cylinders, and cooking equipment.

THE MAXIMUM TOTAL NUMBER OF DAYS A TENT MAY BE ERECTED AT THIS LOCATION IS 180 DAYS. **THIS PERMIT EXPIRES 30 DAYS FROM DATE OF ISSUANCE.**

Permit Conditions

1. Tents, canopies or temporary membrane structures³ shall not be located within 20 feet of: Lot lines; buildings; other tents, canopies or membrane structures used for cooking or cooking booths; parked vehicles; and internal combustion engines (such as generators).
2. Hay, straw, shavings or similar combustible materials shall not be located within any tent, canopy or membrane structure containing an assembly occupancy, except for materials necessary for the daily feeding and care of animals. Sawdust and shavings utilized for a public performance or exhibit are permitted if kept damp. Combustible vegetation and waste material shall be removed from inside and within 30 feet of structures.
3. Heaters and open flame devices are not allowed inside or within 20 feet of a tent, canopy or membrane structure while open to the public, except as specifically approved by the Code Enforcement Officer. Cooking and heating equipment is not permitted within 10 feet of exits or combustible materials. LP-gas containers shall be located outside, at least 10 feet from the structure.
4. Fireworks are not permitted within 100 feet of tents, canopies or membrane structures.
5. Portable fire extinguishers shall be provided in each tent (min. 10-lb. ABC type).
6. Exit signs shall be provided where exits serve an occupant load of 50 or more persons. Occupant load signs shall be posted as specified by the Code Enforcement Officer.
7. Where the occupant load exceeds 300 persons, an approved emergency lighting system shall be provided.

³ For the purposes of determining required distances, support ropes and guy wires shall be considered part of the temporary membrane structure, tent or canopy.
