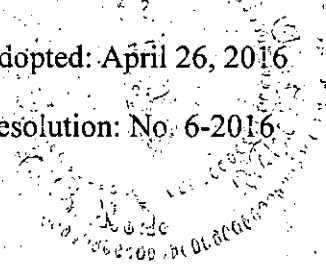

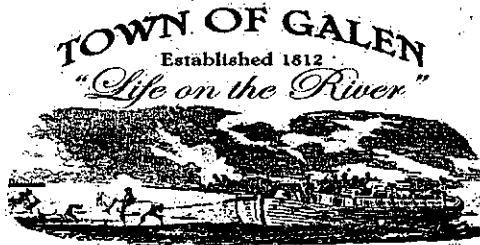

As follows;

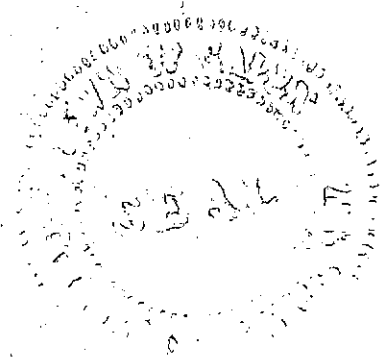
§1 Beginning on the 4th Tuesday of May, and so many days thereafter
